

## THE CONFERENCE

From 28 October through 1 November 1647, Oliver Cromwell, his son-in-law Henry Ireton, and other officers of the New Model army met with activists among the troops to discuss *An Agreement of the People*, a Leveller plan for a radically different English government than had ever been known: one without a king and house of lords, and with a parliament elected on the basis of universal manhood suffrage, or something close to it. This international conference, sponsored by the Center for the History of British Political Thought, celebrates the 350th anniversary of these debates. Papers will address the political, cultural, religious, and military setting of the debates, the debates themselves, and the legacy of the debates and Leveller activism for the Restoration, for collateral issues such as political participation by women, and for later historiography.

## THE CENTER

The Folger Institute Center for the History of British Political Thought was established in 1984 by a grant from the National Endowment for the Humanities. The Center seeks to remap the patterns of discourse in a major political culture over the three seminal centuries 1500-1800. The Center's steering committee is chaired by J.G.A. Pocock, emeritus of Johns Hopkins University, and includes Linda Levy Peck of George Washington University, Gordon Schochet of Rutgers University, Lois G. Schwoerer, emeritus of George Washington University, and Kathleen Lynch of the Folger Institute.


